Current and completed works


- Keypads have been installed on the doors of Ross House and are now up and running. Tenants will still continue to use swipes for daily meetings but for after-hours meeting room access, the user will be sent a unique bookings access code (via a booking confirmation and reminder email) to gain access to that particular floor. If you have any questions regarding this, please contact the Front Desk.
- The ground floor toilet works are underway. We thank you for your patience with the noise and the temporary toilet access to level 1 these works should be completed by the end of November 2018 they will look and feel great when complete!
- A new hot water urn has been installed in the ground level kitchen.


Upcoming works / happenings

- A new TPG fibre 1000 connection is coming to Ross House very soon. This means that the speed of the internet will be ten times faster than it currently is watch this space for more details.
- Variable speed drives will be installed in the air-con system soon this is to reduce the overall power consumption for Ross House and it has been estimated to save around a third of overall usage.

Ross House Association continues to make incredible energy savings as a result of sustainability works to the building, behaviour change and continued commitment from the entire Ross House community.

Grant News

There are many grants open at the moment, but here are a couple that look great.

The IOOF Foundation's Community Grants Program opens on the 15th of November and is offering grants of up to \$150,000, although the average grant amount is approximately \$30,000. Applications are due by 15th January 2019.

The IOOF Foundation provides grants that support Australian not-for-profit organisations working with disadvantaged families, disadvantaged children and youth and aged care.

- Aged care The Foundation will be giving priority to program's that are committed to providing the quality of life for individuals and their families with progressive neurological and physical diseases.
- Disadvantaged families The Foundation's basic needs program, supports community groups that are assisting families that are struggling to be self-sufficient and support long-term solutions that help families move out of poverty or avoid a crisis.
- Disadvantaged children and youth The Foundation supports education projects that help break the cycle of disadvantage and empower young Australian's to reach their potential. Priority will be given to applications addressing:
 - * Prevention and early intervention, and
 - * Education, employment and training for young people.

To be eligible for funding from IOOF Foundation, you must have Deductible Gift Recipient (DGR) status.

Perpetual Limited Grants IMPACT Philanthropy Application Program opens on 29th October 2018 and is offering grants of up to \$200,000, although the average grant amount awarded is approximately \$90,000. Applications are due by 5pm on 7th December 2018.

The program recognises the importance of the philanthropist, good grant making and governance in building a healthy and responsive charitable NFP sector, and is an opportunity for charitable organisations to demonstrate the quality of their work and mission.

You do not need to direct your organisation's application to a specific trust, unless specifically invited to do so. As part of their assessment process, they will match your organisation to all appropriate trusts and endowments.

To be eligible to for funding through the IMPACT Philanthropy Application Program, you organisation must have <u>at least one</u> of the following:

- Be a registered charity on the ACNC register
- Australian Taxation Office Deductible Gift Recipient (DGR!) endorsement
