Future Sustainability

Promoting RHA

- work has started on developing a brochure with historical data and case studies to demonstrate the effectiveness of Ross House
- the Ross House promotional video has been completed and is available via our website
- we have applied for a grant to upgrade the Mezzanine lift; the Ground Level toilets are completed and further building work is planned to make the building more inviting to the public

Efficient use of resources

- we have a group of consultants working for us, pro-bono, who are offering legal, heritage and building advice, regarding how we can best use the space above our building
- we have been in discussions with real estate consultants, who are giving us ideas on how to develop a value aligned commercial space at Ross House
- we are currently assessing office space, ensuring we are using our spaces as effectively as possible. Membership criteria is currently being reviewed.

Plans for securing the future

- operational and work plans have been developed and work on updating our 10year capital works budget has commenced
- Deductable Gift Recipient (DGR) status has been followed up the issue remains that without major changes in membership and tenancy, RHA is not eligible as a Public Benevolent Institution (PBI) and therefore DGR. We are unable to split into another Trust as we are not an education or arts organisation.


Upcoming works / happenings

Our Finance sub-committee has been working hard to contain any increases, as we head to our next annual budget for Ross House. This sub-committee now also covers risk management as these two items are closely related.

The strategic plan continues to take shape in its implementation. This very important work is occurring behind the scenes with legal research and clarifications occurring on some items. We need to do our best to get all the information possible, even if it means it takes longer for aspects to come to back to the community for comment.

As Amber Moore, our Development Program Manager, has advised, on Wednesday 1st May 2019, the launch of the new accessible ground floor facilities will take place. Melbourne Metro Rail Update

The following works are either underway or planned for the Melbourne Metro Rail Project:

- \diamondsuit the piling works at the Flinders Quarter site is underway and will continue to December 2019
- ♡ Melbourne Metro have installed a noise monitor outside of the DWA/Spina Bifida tenancy on level 4.
- \Diamond 15-30 trucks a day are expected to remove spoil from piling works; access will be via Swanston and Flinders Streets
- ≎ the City Square site acoustic shed will go up in March & April 2019
- ♡ the steel deck over the Flinders Quarter site is likely to be pushed back until after the piling is complete
- ₩ excavation and tunnelling will begin once the deck is in place

Accessible Ground Floor Facilities Launch

It has been a very long time coming, and the works took a lot longer than expected (due to this old building throwing some unexpected challenges at us), but we are happy to report that the upgrade to the ground floor bathrooms is complete.

Previously we had only one unisex toilet and one disability toilet (which was not DDA compliant) on the ground floor. The upgrade has meant that we have been able to build a fully accessible DDA compliant bathroom and shower facility, a female bathroom (including ambulant toilet, single pan & shower) and male bathroom (including single urinal, single pan & shower). The changes have made an incredible improvement to the amenities we can offer tenants and visitors to the building.

Completing this project has created significant social benefits to our community by ensuring that Ross House is an all-inclusive and accessible community hub and that equal access is provided to all.

RHA was fortunate to receive funding through both the City of Melbourne and the Australian Government to put towards this project and for that, we are very grateful.

To mark the occasion of improved accessibility within Ross House, we are having a little morning tea to celebrate the completion of the ground floor amenities.

Ross House booking system trouble-shooting

We are really delighted to see that the Ross House online booking system is working well for the community. Having a handle on the system allows you to manage bookings, update contact details and add people to your key register. Over the past couple of months however, we have noticed that some of the issues people are facing with the system can be (or a combination of), the following:



- Are you using a 24-hour clock when selecting the booking times? If not are not, your booking will not save properly. Please make sure you use 24-hour times.
- Have you filled out the billing information correctly? When you first get to

 your payment information, if this is not filled out correctly, it may restrict you

 from moving through to complete the booking. Please note, you only have to do this process once.

- Is your booking in your cart? Often this can happen if you have a pending booking. What this means is that the system is holding it for you in the cart. You can access your cart in the top right hand corner.
- Have you tried logging in and out again? This helps to restart the system we often do this at Ross House.
- Are you using Google Chrome? Internet Explorer is not compatible unfortunately.
- Did you know that your username is not your email address? Your username is separate from your email. If you require your username, please contact the Front Desk
- Have you cleaned your cache lately? Your cache stores data, which needs to be cleared every now and then to make sure you are seeing updated webpages. You can clean cache by clearing your browsing history.

Grant News

There are many grants open at the moment, but here are a couple that look great.

The Helen Macpherson Smith Trust Impact Grants program is now open, with submissions due 6th June 2019 at 12pm. Grants of between \$91,000 to \$200,000 are available.

Impact Grants respond to larger funding requests for well-developed projects, with clearly defined milestones based on solid data. At this grant level, the trust is looking for proposals that have a strong potential to achieve significant outcomes within their program focus areas. The type of activities that may be considered include those that: will result in benefits across multiple organisations or communities; have substantial reach in beneficiary numbers; or take a new approach to an identified sector issue within one of their focus areas.

Focus areas are:

- education
- ☆ community
- arts and culture
- environment
- ☼ health

Impact grants are by enquiry only. Initial consultation with HMSTrust Grants staff is required and it is recommended to make contact with them as soon as possible.

Deductible Gift Recipient status is not required.

The Australian Communities Foundation provides funding for charitable organisations all year round. Funding of between \$2,000 (approx) to \$15,000 (approx) is available.


Australian Communities Foundation (ACF) supports a range of charitable organisations and projects each year.

To be eligible for funding:

- your organisation must have both TCC (Tax Concession Charity) and DGR item 1 (deductible Gift Recipient) ATO endorsements, and
- the activities for which you are seeking funding, as outlined in your proposal, must be charitable and in line with your organisation's charitable purpose.

Community Music Victoria (CMVic)'s Flinders Lane Community Choir is back for an exciting local singing group for anyone living or working around Flinders Lane.


CMVic are holding continuous sessions in the Mezzanine room on Thursday afternoons, no need to book, just turn up!






Human Rights Arts and Film Festival (HRAFF)
