Upcoming leasing campaign for a value aligned commercial space at Ross House

As part of our commitment to the Ross House Association 5-year Strategic Plan, which was developed through a comprehensive community consultation process in 2017 & 2018, the Association recently carried out a leasing campaign for the ground floor of Ross House. After six weeks, we have now concluded the campaign and have received a number of offers.

The RHA Committee is looking closely to see if any of the offers are suitable for Ross House, if the Committee decides that an offer is suitable, we will then ask for the community to submit feedback via written or recorded media, prior to entering into any lease agreement. This process will likely happen mid to late September.

Melbourne Metro Rail Update

The following works are either underway or planned for the Melbourne Metro Rail Project:

- The piling works at the Flinders Quarter site has started and will continue through to December 2019, two piling rigs are in place.
- The steel deck over the Flinders Quarter site is likely pushed back until after the piling is complete.
- Excavation and tunnelling under the Flinders Quarter site will begin once the deck is in place.
- The City Square site acoustic shed is under construction and will be completed in November 2019.
- City Square excavations and tunnelling have commenced.




Ross House Association continues to make incredible energy savings as a result of sustainability works to the building, behaviour change and continued commitment from the entire Ross House community.

This month, there is a noticeable difference in our electricity usage (see purple line on graph). The reason for this is the variable speed drives that were installed, as part of our air-conditioning system, earlier this year. This means that the speed of the fans for the air-conditioner can be changed according to the requirements of the room temperature.

Reflections by the RHA Chairperson - Christine McAuslan



There is a lot happening around Ross House, in what has been a busy year for the committee and staff.

Work continues on planned aspects of keeping the House sustainable into the future as underpinned by the Strategic Plan.

We have received some expressions of interest in leasing the ground floor. These were examined with great care regarding their suitability at the August Ross House Association Committee meeting. The process for coming to any decision will be adhered to. The timeline for the various aspects of decision making is on track with Community Consultations taking place between 30th September and 24th October.

With a new lift about to be installed in Ross House over December (through to mid-February), the Committee realises there will obviously be some disruption for all of us

who use Ross House. However this disruption will result in a new, slightly larger and somewhat faster lift, which will enable reliable access to all floors.

A special thanks to Amber Moore, Development Program Manager and Michael Griffiths our General Manager, for obtaining some alternative accessible space at the nearby City Library for the period when our new lift is being installed. This space will be booked via Ross House so please talk to staff if you feel you may need to utilise this space.

The revived Community Development Sub-committee will meet soon. We are in the process of organising a date and time of mutual availability for those who have put their hand up to participate.

Other works that various committee members are involved in are a new Enterprise Bargaining Agreement with staff and the annual report back of staff reviews.

As we head towards our Annual General Meeting in November we will be looking for participation on the Committee. Our General Manager and I will organise an information session for anyone who wants more information on what is involved.

Phone information for tenants

Please note that you need to start making plans for switching your telephone service.

If you have a traditional copper service e.g. a PSTN (traditional home phone) or ISDN (multiple lines) service, you need to plan to change to a VoIP system that runs off a fibre network.

Some of you have already made the transition, but we understand that there are still some tenants using a traditional phone service.

The Government via its NBN rollout will be switching off the copper network in Flinders Lane on the 8th May 2020.

Any new phone system that you decide to proceed with will run over the Ross House Fibre 1000 internet service.

Grant News

There are many grants open at the moment, but here are a couple that look great!

The Lord Mayor's Charitable Foundation's Seed Innovation Grants support projects or initiatives aligned with one of more outcomes of the Foundation's revised Impact Areas. Seed Innovation Grants are for up to \$50,000 for one year and support the researching, testing and piloting of a new idea or approach. This can include:

- Project funding to test, demonstrate, trial or pilot a new concept or idea that will lead to a service improvement or an advance in a major community issue
- Research funding to build understanding of an area or issue.
- Inform program design or practice, inform policy development and philanthropic investment or identify best practice.
- Funding to support the initial development phase of a social enterprise that addresses at least one Impact Area Outcome.

Impact Areas are:

- Education & Employment and Environmental Sustainability
- Healthy & Resilient Communities and Homelessness & Affordable Housing

Grants are due at 5pm on 16th September 2019.



SHINE for Kids supports children, young people and families with relatives in the criminal justice system. They have been operating for over 30 years and have programs in VIC, NSW, QLD and the ACT.

SHINE stands for the five elements of what they do: **Support** children, facilitate **hope**, **inspire** kids to reach their potential, **nurture** their growth and **empower** them to succeed.

In Victoria, they are growing their programs to meet an ever-increasing need. Currently they support children, when visiting their parents in prison, provide a supported transport option for children who are unable to visit otherwise and provide educational support for kids with an incarcerated parent.

SHINE has volunteer opportunities including prison-invisits, mentoring, children's transport, education support and child family days. This would suit anyone looking to fill a few hours in the week, use or improve your digital skills and make a real difference in children's futures.

Please note that SHINE undertakes several screening processes to ensure the appropriate protections of children in its care. This includes reference checks, identity checks, qualification checks and professional registration checks.
