CORONAVIRUS (COVID-19) UPDATE 21 - Further Update to Restrictions

The State Government has further relaxed COVID restrictions. The following rules will apply from 11:59pm on Thursday 24th June 2021. Please see the below changes to the Ross House COVID policies:

- ⚙ No stay at home requirement.
- ⚙ Movement between metropolitan Melbourne and regional Victoria is unrestricted.
- ⚙ Face masks need to be worn indoors at all times. They are still recommended outside where a 1.5m distance cannot be maintained. Exemptions still apply.
- ⚙ For Ross House meeting room spaces a density quotient of 1 person per 4sqm still applies, as we are unable to have a COVID Check-in Marshal present at all times due to after hours and weekend bookings. You will need to have a COVIDSafe Plan and use the QR code sign in at Ross House.
- ⚙ The if you can work from home, you should continue to work from home advice has been removed. For office work, 75 per cent can return or up to 30 people if the total workplace is 40 people or less.

Given the above change, Ross House will have two staff present each day during the week from Monday 28th June 2021. For meeting room bookings and other enquires please contact us via email at rosshouse@rosshouse.org.au or on 9650 1599.

- ⚙️ Painting on Level 3 has been completed. You will notice the vibrant purple as you enter and walk the floor.



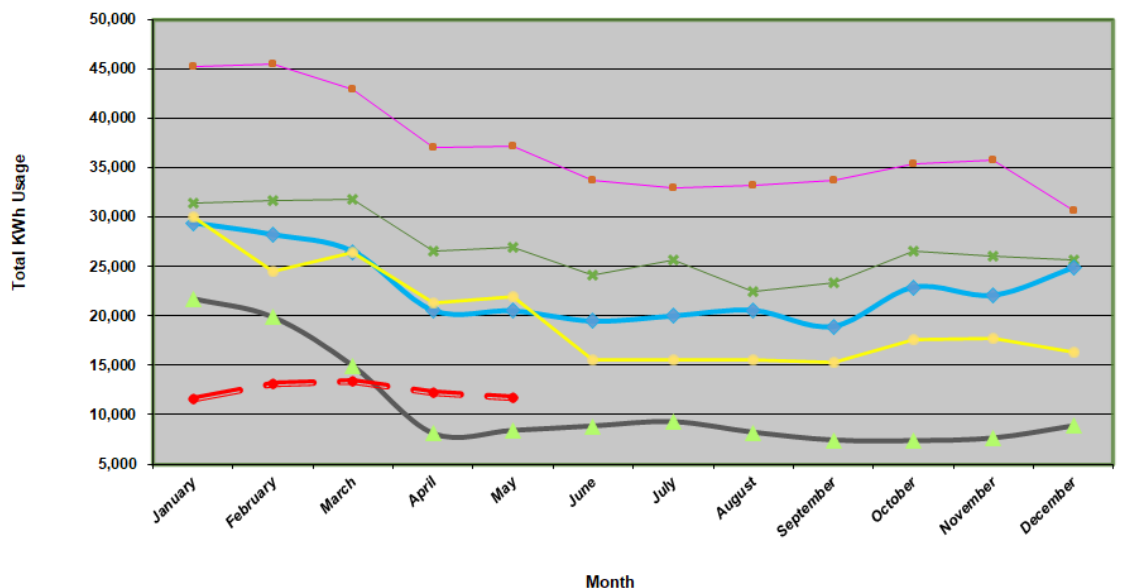
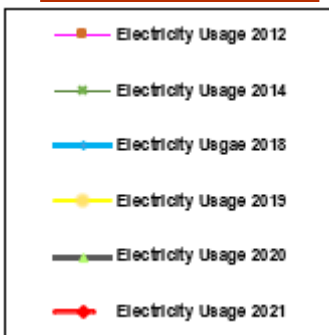
Upcoming works / happenings

Reflections by the RHA Chairperson

Despite the current times and restrictions, due to COVID and its impacts, Ross House at the moment is doing OK. It is of course pretty quiet in relation to what was the 'normal' hustle and bustle of the House that made it such an interesting and active space to be part of.

Meanwhile, until we can get back to something like we previously knew, there have been changes as tenancies move to occupy bigger or smaller spaces around the building, according to their needs. Our old building continues to require attention as was experienced by some 4th floor tenants when guttering problems on the Royston Lane side of the building occurred and there were consequent leakages. Expenditure for replacement guttering was approved at the June Committee of Management meeting.

Many of you may be aware of the potential for a Safe Injecting Room in Flinders Street (the old Yooralla building). The Committee is watching this and other changes that may eventuate in our neighbourhood to assess what the impacts, if any, may be on our community.



Ross House Association joined forces with Deafblind Victoria in their application for the Information, Linkages and Capacity Building Economic and Community Participation Program – Social and Community Participation Grant Opportunity 2020-21. This application was successful and we congratulate Ntennis Davi from DeafBlind Victoria and our General Manager Michael Griffiths on their efforts in achieving such a positive result.

We continue to apply for applicable grants as they emerge. Recently we have submitted to the Powering Communities 2021-22 - Expressions of Interest for the installation of LED lights in the House. The program provides grants to not-for-profit community organisations to improve their energy efficiency practices and technologies.

In conversation with Michael our General Manager, he observed that many external organisations that he has to deal with are very much in hibernation mode, as responses to queries are taking much longer than is usual. Generally, I have found amongst my friends and colleagues expressions of a lack of motivation that has hit many of us as we hunker down through another COVID winter.

However, as groups look to creating their budgets and preparing end of year financial reports it is understandable this may be more difficult with so many unknowns to acknowledge going forward. This is why it is important to also acknowledge all the great work that continues in maintaining groups and organisations associated with Ross House. I include Ross House staff and committee members in that acknowledgement and thank them all for their unstinting contributions.

Please keep warm, safe, well and be kind to yourselves and each other.

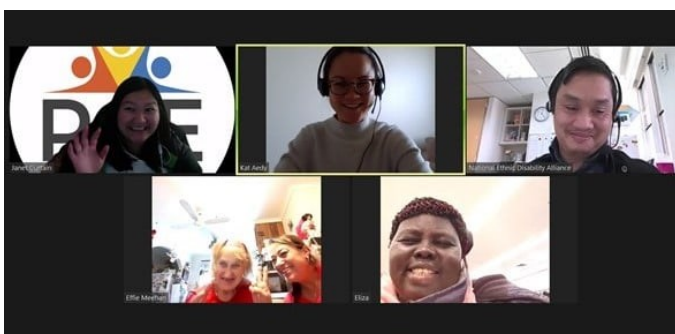

Grants and other support during the COVID-19 crisis

These are some of the grants and COVID assistance programs currently available:

Department of Home Affairs

COVID-19 Disaster Payment

The purpose of the grant is to provide financial assistance for eligible individuals who are unable to work (and earn an income) under a state public health order for a lockdown that is greater than seven days.

COVID-19 Disaster Payment grants are administered by Services Australia on behalf of Home Affairs from 1st July 2021, on behalf of NRRRA. The COVID-19 Disaster Payment grant program will run from 8th June 2021 and will end when determined by the Australian Government. Eligibility requirements:

- ⚙ For a person who would have otherwise worked for up to 20 hours of work in the relevant period, the amount of COVID-19 Disaster Payment payable to a person is \$325.
- ⚙ For a person who would have otherwise worked 20 hours or more in the relevant period, the amount of COVID-19 Disaster Payment payable to a person is \$500.

Claimants are required to complete an application form online via their myGov account. Claims will be accepted by telephone in limited circumstances.

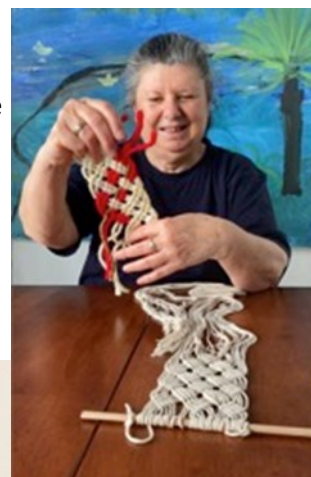


Deafblind Awareness Week with DBV

Disability Resources Centre (DRC) Executive Officer speaks at the launch of the People's Climate Strategy

DRC and Friends of the Earth (FOE) have been in partnership since 2019, when a chance encounter between staff from the two organisations revealed an alignment in mission. FOE follows the principle of climate justice, which acknowledges that action on climate change must be led by social justice principles. They were willing to support DRC's work in any way they could, and we discovered that our *Transport for All* campaign shared goals with FOE's Sustainable Cities project. Since then, we've collaborated and shared skills whenever possible. Most recently FOE staff and supporters joined our direct action to demand an accessible Melbourne tram network.

Over 2020, FOE launched an ambitious project to develop a community-led People's Climate Strategy, in lieu of the state government strategy delayed by COVID-19. Knowing that the disability community is uniquely affected by both climate change and attempts to address it, FOE asked Kerri Cassidy to speak at the People's Climate Strategy Launch on Thursday 22nd April at Trades Hall. Kerri's speech talked about natural disasters, Climate Darwinism and called for rapid systemic change, as it makes people with disabilities more vulnerable. She also highlighted how these vulnerabilities make it crucial for the disability community to be involved in climate action.

Melbourne Metro Rail Update

Please see the latest updates from the Melbourne Metro Rail Project:

- ⚙ Individual train stations now starting to take shape.
- ⚙ TBMs Joan, Meg, Millie and Alice have completed their sections of the Metro Tunnel.
- ⚙ The arrival of TBM Meg at the Town Hall Station site marks the completion of major tunnelling works for the project.
- ⚙ Flinders Street footpath has now reopened, however there will be occasional temporary closures.
- ⚙ Construction works within the Town Hall Station precinct during June 2021 include:
 - ⚙ Roadheader tunnelling
 - ⚙ Underground platform construction
 - ⚙ Shaft construction works within the Flinders Quarter site
 - ⚙ Service investigations on Swanston Street
 - ⚙ Campbell Arcade connection works
- ⚙ The Flinders Quarter art walk has been extended for an additional 6 weeks due to popular demand, now running from 14th August - 31st October 2021. This is an interactive exhibition with art pieces hidden around the Flinders Quarter Area.
- ⚙ Flinders Street will be back open to east bound cars from January 2022.
- ⚙ Works are on track despite COVID-19, some work has been easier due to reduced traffic and pedestrian flows.
- ⚙ Construction of the Oversight Development (OSD) will commence once a concrete slab has been installed at the Flinders Quarter site. Expected in 2022.

FAQs for members and tenants

With the everchanging times, we have updated the list of FAQs for members and tenants.

Q. Is Ross House open?

A. During the COVID-19 period, there are 4 reasons to be in Ross House:

- ⚙ You are working for an organisation that is a tenant
- ⚙ You have a booked meeting at Ross House
- ⚙ You are accessing the services of a tenant
- ⚙ You are accessing your pigeonhole for mail

Ross House is open to tenants, members and meeting room users. It is not open to the public – the front doors will continue to be locked until further notice.

Q. Can I access my office?

A. Yes you can. Please make sure you have your swipe and office key. If you are returning to work, please make sure you have a COVIDSafe plan. For more information, please visit www.coronavirus.vic.gov.au/covidsafe-plan.

Q. What is the cleaning situation at the moment?

A. With more groups returning to the office, RHA has increased the cleaning schedule from three days to five days.

Q. Do I need to sign in to Ross House?

A. Yes, please use the Vic Government contact tracing system to sign in which is located on the entrances, meeting rooms, lift and levels to Ross House. Tenants should also have in place their own QR system under their COVIDsafe plan. If you need help, please contact the RHA team.

Q. What is happening to my mail?

A. RHA staff will distribute mail daily at Ross House. In the event of an extended lockdown, mail to the membership will be scanned and forwarded on to the main admin contact. Deliveries can be accepted by RHA staff (at Ross House) during off-peak business hours (Monday – Friday, 10am – 3pm). If there is anything important you are waiting on, please inform Katie on rosshouse@rosshouse.org.au / (03) 9650 1599.

Q. Can I book a room?

A. Yes, you can book a meeting room via your online account. If you need assistance, please contact Katie on rosshouse@rosshouse.org.au. However, here is some information about getting into the building (for room bookings):

- ⚙ please check your booking email confirmation/reminder to obtain your four-digit access code - this unique access code will give you access the building/floor that you need.

Q. Can I book a car space?

A. Yes, please contact RHA on (03) 9650 1599 to book a spot.

Q. Our organisation has grown and we may need a larger office. What is the process?

A. Please contact Rebecca, the Membership and Tenancy Officer directly to discuss your options - rebecca.may@rosshouse.org.au. There are currently some offices available and if these are not suitable, then you will be able to go on a waitlist.

Q. Our organisation has had to downsize during the pandemic and we may need a smaller office space. What do we do?

A. Please contact Rebecca, the Membership and Tenancy Officer directly to discuss your options rebecca.may@rosshouse.org.au. There are currently some smaller offices available and if these are not suitable, then you will be able to discuss your needs and timeline and go on a waitlist.

Q. We need to re-organise our work space and have furniture we need to get rid of. Does Ross House provide hard rubbish collections?

A. Ross House organises two gratis hard waste collections per annum for odd items that tenants may need to discard. Please note that this is a service provided to all tenants and not on an individual needs basis. Notwithstanding this, should you require a specific office hard waste collection that involves multiple items, the cost is \$100 per m3. Disability Resources Centre's campaign for Accessible public transport

Back in February 2021, DRC launched a petition urging the Victorian Government to make the Melbourne tram system work for everyone. We all know that affordable, reliable and accessible public transport is integral to independence, and that 71% of our community does not take public transport because of barriers to access. And yet today, 85% of the tram network is still inaccessible. 10,725 people signed the petition and in early May a small group of campaigners presented it to the Minister for Public Transport, the Hon. Ben Carroll. The Minister was knowledgeable and responsive. As Melburnians shared their stories of exclusion, we felt that he and his team genuinely heard us.

In March the disability community teamed up with Friends of the Earth and the Rail, Train and Bus Union to take to the streets in a direct action. We stopped a tram in Spring Street, Central Melbourne, and heard from campaigners who have been lobbying for change in the transport space for over 40 years. The protest was covered by Channel 9 News.

The State budget did not deliver the great commitment to infrastructure upgrades we were longing to see. However, there is much to be positive about in the commitment to produce a Public Transport Accessibility Strategy. While some are surely disappointed by the thought of another year spent planning and not acting, the State Government has acknowledged that the absence of a holistic approach to the accessible stop upgrades has been responsible for many delays, and in the past each stop has taken two to three years to complete.

We will be lobbying to see a reasonable time frame attached to the Strategy production and its execution, and, as ever, we will be campaigning to ensure that this is evolved through regular and transparent engagement with the disability community.

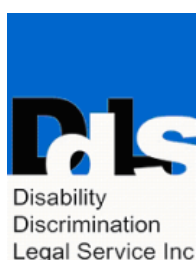
